

#### Media Services:

EFHOH, EDF, and Broadcasters drew up a common proposal to improve access to audiovisual media services. The European Disability Forum (EDF), the European Broadcasting Union (EBU), and the Association of Commercial Television in Europe (ACT) have made a common proposal to improve the accessibility of audiovisual media services for persons with disabilities. Broadcasters and the umbrella organisation of the European disability movement reached this agreement upon the initiative of the Member of the European Parliament (MEP) Petra Kammerevert, who is preparing the European Parliament's report on the revision of the Audiovisual Media Services Directive (AVMSD).

EDF, EBU, and ACT (the "signatories") released a common proposal to introduce progressive and sustainable measures for the delivery of accessible audiovisual programmes in Europe. The signatories expect these measures to enhance the accessibility of TV programmes for persons with disabilities, via subtitles for the deaf and hard of hearing, audio description, spoken subtitles and sign language interpretation, also known as access services.

The common proposal aims to improve existing wording on audiovisual accessibility under Article 7 of the 2010 Audiovisual Media Services Directive (AVMSD), which EU legislators are currently reviewing. A large number of stakeholders and EU decision-makers have highlighted the need to maintain and develop the AVMSD's provisions on access services. Read more on EDF's website

#### Inclusive Workplaces:

Some weeks ago, I was in Malta and represented EFHOH at the European Conference on Inclusive Workplaces 2017. Work and employment are important aspects of everyone's life. However, more than half of the people with disabilities in Europe are unemployed and face a higher

risk of poverty or social exclusion. Women with disabilities face multiple discrimination both on the grounds of gender and on the grounds of disability. The EDF board recently adopted a resolution to highlight key issues and called for concrete actions from the institutions of the European Union (EU) and its Member States.

# We need to be **assertive** to exercise our own rights

Since I gualified as a mentor I have had the opportunity to train hard of hearing students in Poland's leading University, the Catholic University of Lublin (KUL). I have my own personal connection with KUL going back to the time when I was a student of psychology and theology in the University faculty operating in my city, Lodz. I did not finish the course unfortunately as I left Poland to take up a scholarship at London College of English.

So, I was delighted when the University Professor Dr. Ewa Domagala-Zysk asked me to help the students and lecturers at the Uni. (pictured)

The Professor is a pioneer in Poland, who developed teaching resources for deaf and hard of hearing students learning English. She has recently published her work" English as Foreign Language for Deaf and Hard of Hearing Persons."

She travelled throughout Europe, making contacts with other Universities and organisations to seek support for her work. This is when she came across European Federation of Hard of Hearing (EFHOH) and my name. We were organising an event in Warsaw to raise awareness of the needs of hard of hearing people with a group of young people. During the event, I gave a taster session on assertiveness and it proved to be the start of my professional engagement with the University.

At first, I was to develop a mentoring program and provide role model as a hard of hearing / deafened person using English as a foreign language, but it became increasingly evident that the students would benefit from assertiveness training as well.



The University then came up with a new programme under the EU funding streams, where assertiveness would be also offered in group training coupled with lectures. This is how I became their visiting lecturer!

People who experience hearing loss tend to lose their confidence due to their inability to hear well and unfortunately, this leads to anxiety and often depression. I attended the Late Deafened Congress in Netherlands, organised by Stitching Plodsdoven, where I learned about their system of social care workers who are immediately

sent to support those who experienced sudden hearing loss, as well as receive referrals to support hard of hearing and deafened people. As part of the rehabilitation, they offer information about benefits and rights, communication support available as well as lipreading, sign supported language and....assertiveness classes!

# **NEW WAYS IN GRECE:** TELEVISION SPOT BY THE GREEK ASSOCIATION **AKOUSTIRIXI** TO PROMOTE AWARENESS

The Greece-based association Akoustirixi created a highly artistic television spot, with the help of over 30 professionals and other people aware of what Akoustirixi seeks to promote. It must be noted that this organisation was founded with a view to helping Hard of Hearing with oral language and providing information on the latest medical and technological developments about complete or partial loss of hearing.

The television spot was shown by all Greek channels for one month (throughout October 2016). Its main protagonist is Thodoris Giotis, a ten-year-old boy wearing a cochlear implant as he was born deaf. He is surrounded by Sofia Kolotourou, the president of the above-mentioned association, as well as by famous artists and athletes, including female Greek singer Rita Antonopoulou, Greek actor Akis Sakellariou and Ms Voula Kozompoli, president

of the Hellenic Olympic-Winners Association and Olympic medalist in water polo. Sofia Kolotourou has been struggling to improve the lives of Hard of Hearing for years. In fact, she has been suffering from hearing loss herself since early childhood, and uses oral language to communicate with other people.

Never had Greek channels allocated time to the issue of cochlear implantation before. In Greece, people are not fully aware of this technology, although cochlear implantation has been a routine procedure since 1993; in fact,

### Make a sound investment - prevent and treat hearing loss

In the EU, around 52 million people report having a hearing loss. The costs in the EU of not treating hearing loss is around 178 billion Euros every year. The societal costs of treating hearing loss are extremely low compared to the cost of NOT treating hearing loss. It's a sound investment.

March 3 is the official WHO World Hearing Day. Hearing loss is one of the disorders that both affects most people and has a great impact on people's lives and health. But hearing loss is also among the disorders that can be treated and prevented most efficiently and cost effectively.

Several surveys in Europe have shown that between 10-12% of all adults self-report that they have a hearing loss. This means that more than 52 million people in the EU will say they have a hearing loss.



On a world-wide basis, the WHO has found that unaddressed hearing loss, using their figures on the prevalence of measured hearing loss, poses a high cost for the economy globally, namely \$750 billion annually. In the EU, the societal cost of untreated hearing loss is therefore estimated to be 178 billion Euros each year.

"There is a saying that says "What is saved is earned". But in the case of hearing loss small investments in prevention and treatment of hearing loss leads to major savings. We must take action for untreated hearing loss. It is a sound investment.", says EHIMA General Secretary Soeren Hougaard.

"First of all, it is important to prevent hearing loss. Especially protection against loud noise and loud sounds is important. At the workplace but also more and more in our leisure time. But far more people can be treated for their hearing loss and thereby increase their quality of life. Today there are many people who live with an untreated hearing loss", says AEA president Mark Laureyns.





Among the major costs of not treating hearing loss are increased health care costs. It is documented that hearing loss is associated with depression, cognitive decline and dementia. Another major societal cost of untreated hearing loss is **increased unemployment**, premature retirement and lower tax revenues and other societal cost because of withdrawal, communication difficulties and social isolation. Furthermore, untreated hearing loss results in additional educational support and costs.

"Society will benefit to a large scale from increased hearing loss treatment. Society will get enormous benefits from reduced costs to health care, unemployment benefits and pensions and other social costs, and at the same time get increased tax revenues. The societal costs of treating hearing loss are extremely low compared to the cost of NOT treating hearing loss", says EFHOH vice-president Lidia Best.

### IFHOH President's Message for EFHOH:

# SDGs as Instruments for Change

I write this message from Athens where I am attending a week-long meeting of the International Disability Alliance, representing the International Federation of Hard of Hearing People (IFHOH). Discussions are being held about a new funding project of IDA which gives increased momentum to its work in developing countries in particular and to its use of the Convention on the Rights of Persons with Disabilities and the UN Sustainable Development Goals (SDGs) as instruments for change for persons with disabilities.

One of the participants commented that, while her members understand the importance of the CRPD as an instrument for change, it is more of a challenge to explain the value of the Sustainable Development Goals. This is understandable insofar as the SDGs are theoretical constructs; they have the ability to influence actions but only to the extent that they are taken seriously by UN officials, governments and civil society which includes us.

The SDGs are goals to promote peace, planet viability, and wealth-sharing. They were adopted by member states of the UN in September 2015 and are expected to be achieved by 2030. In the preceding decade there were Millennium Development Goals but those goals did not mention persons with disabilities at all. Now we are included! There are 17 SDGs and, because of the work of IDA and allies in civil society and various governments, the SDG indicators contain 11 references to persons with disabilities with the potential for many of the generic goals to be assessed in terms of progress for people with disabilities.

Among the SDGs most applicable to our community are, as summarized below:

- Goal 3: Striving for good health
- Goal 4: Equal and inclusive education
- Goal 5: Equality and empowering women and girls
- Goal 8: Access to employment opportunities
- Goal 10: Support marginalized groups such as people with disabilities to have the same opportunities as everyone.
- Goal 11: Safer, more inclusive cities and other places
- Goal 12: Fair share of goods and resources and enough for all
- Goal 16: Peace, justice and equality for all

If we take the Goal #4 on equal and inclusive education, as an example, it means that all girls and boys should complete primary and secondary education. The sad fact is that, as of 2013, there were 59 million children of primary age who are not in school.



However, completion alone is not enough. The education must be of quality and it must be inclusive. This means that children who are hard of hearing and deafened must have access to the verbal content in the classroom. They must be able to "hear" what is being said by the teachers and other students, through environmental design that maximizes classroom acoustics, through use of technology and devices that amplify sound (including hearing aids and cochlear implants) and through use of captioning/notetaking. As well, teacher practises need to be inclusive so that hard of hearing children are not simply occupying a seat, but are hearing, learning and participating like all other children.

So, as you can see, the SD Goal #4 is very important and we as a community need to hold the government of our country accountable for the achievement of this goal. You can take action to develop a report card on the SDGs and evaluate your government's performance and let them know that you are doing so.

IFHOH will provide resources and support to you through its Human Rights Initiative. We will continue to track developments at the international level and we will continue to provide information on how to apply the CRPD and the SDGs to uphold the needs and rights of people who are hard of hearing and deafened. ### A «Saint» for People with Hearing Loss

Margarethe von Witzleben died 100 years ago

The first association for hard of hearing and deafened people worldwide was founded in Berlin, Germany in 1909.

Margarethe von Witzleben (1853-1917), who became hard of hearing at the age of 13, organized the first worship service for hard of hearing and deafened people in Berlin in 1901. 8 years later she organized the first self-help group for people with hearing loss called "HEPHATA" in Berlin. Today, February 1, 2017 is the 100th anniversary of her death.

The Hearing Loss Association of Germany (Deutscher Schwerhoerigenbund e.V.) today walks in the footsteps of Margarethe von Witzleben and will host "Future Loops" the 4th IFHOH International Hearing Loops & Accessibility Conference in Berlin, Germany, October 6-8, 2017.

### "Action for Hearing Loss - Make a Sound Investment". Lunch **Debate** at the European **Parliament**

AEA-EFHOH-EHIMA jointly organized the Lunch Debate in Brussels on the 1st March as part of World Hearing Day. The event was hosted by MEPs Helga Stevens and Roberta Metsola.

Helga Stevens emphasized in his opening speech that most young people don't understand the importance of adequate hearing protection. According to WHO's technical officer Shelly Chadha, unaddressed hearing loss has a significant cost worldwide, in Europe up to 178 billion € annually. Chadha pointed out that by effective screening hearing losses could be detected in time.

Mark Laureyns from AEA told that there are 52 million hard of hearing people in Europe with self-reported hearing loss. Only about 60 percent of persons who would benefit from hearing care have currently access to it.

Health economist Laurence Hartman stated that one euro invested in hearing care saves ten euros due to the consequences arising from communication problems in daily life.

EFHOH's Vice president Lidia Best emphasized the human rights perspective: the access to affordable quality hearing care is a right. People shouldn't be excluded from hearing care due the cost issues.

The event was concluded by Roberta Metsola, who called for more action to bringing out the hearing disability issue. Metsola stressed that Europe should be at the forefront in addressing the challenge of hearing loss, especially adult screening should be developed.

### WHO highlights the high global cost posed by unaddressed hearing loss

1 March 2017 ¦ GENEVA: On the occasion of World Hearing Day, 3 March 2017, the World Health Organization (WHO) is drawing attention to hearing loss, its economic impact and the cost-effectiveness of interventions to address it. 360 million people worldwide have disabling hearing loss; 32 million of them are children. Factors contributing to hearing loss

include genetic causes, complications at birth, certain infectious diseases, chronic ear infections, the use of particular drugs, exposure to excessive noise and ageing.

This year the theme of World Hearing Day is "Action for hearing loss: make a sound investment". In a new report released today, Global costs of unaddressed hearing loss and cost-effectiveness of interventions, WHO estimates that lack of attention towards hearing loss poses an overall annual cost of 750 billion international dollars globally. The financial costs to the health sector alone are 67-107 billion international dollars every year.

#### Hearing loss can be addressed

In some settings strategies to prevent hearing loss are well-established, and the actions taken in those settings have resulted in financial

savings and significant return on investment. The establishment of early intervention programmes is improving access to ear and hearing care services generally. Moreover, technology is available to detect hearing loss at the earliest stage of development. When their needs are met, people with hearing loss are better able to access education, learn skills and be employed.

#### Interventions to address hearing loss are cost-effective

WHO's new report focuses on solutions for lowering the prevalence and mitigating the impact of hearing loss. It highlights cost-effective strategies, namely:

prevention through early identification and treatment of ear infections and reduction of noise exposure;

- early intervention programmes that help identify hearing loss through the screening of newborn and school-aged children and adults above 50 years of age;
- provision of appropriate hearing devices, accompanied with rehabilitation.

"Unaddressed hearing loss poses a great challenge not only for those who are affected by it, but also for their families, communities and countries," says Dr Etienne Krug, Director of the WHO Department for Management of Noncommunicable Diseases, Disability, Violence and Injury Prevention. "Cost-effective interventions can reduce the impact of hearing loss and ensure that people with hearing loss have the same opportunities in life as their hearing peers. These interventions, which bring benefit to people and save costs to governments, should be replicated wherever there is a need."

This report forms part of WHO's advocacy efforts to promote global action on hearing loss and calls upon policy-makers to address this challenge through:

- allocation of suitable resources;
- planning strategically to integrate ear and hearing care into health systems;
- training appropriate human resources;
- implementing early identification and intervention programmes;
- establishing awareness programmes.

### Press release: 112 Day - New technology improves location of emergency calls and helps EU citizens

On Saturday 11th February, the European Union celebrated 112 Day - the day of the Single European Emergency Number. With an average of 255 million mobile emergency calls every year, a new technical solution helps to provide accurate caller location for people in distress.

Europeans can dial 112 for free in any EU country if they need to contact emergency services, thanks to EU legislation, introduced in 1991. Every year, about three hundred thousand people who call the emergency services cannot describe their location, because they may not know where they are, because they are too young to say, or too injured to communicate. In these situations, knowing the exact location of the caller can help emergency services to react guickly and save lives.

Today's mobile and smart devices are able to provide emergency services with accurate caller location via an SMS or data channel by using in-built Global Navigation Satellite System (GNSS) or Wi-Fi capabilities. A report published today shows significant improvement for caller location in several EU countries. Lithuania upgraded its network based location solution to ensure significantly more accurate caller location. UK and Estonia deployed the Advance Mobile Location (AML) handset-based caller location solution which can locate a person to within 100m. An EU-financed project - HELP 112 – looked into how GNSS can improve caller location using the AML solution. It was tested in the UK, Lithuania, Italy and parts of Austria. Currently AML handset based caller location for emergency services is available only on Android phones.

Mr Andrus Ansip, Vice-President for the Digital Single Market, said "I welcome this very important step which helps people in distress and showcases how digital technologies can make our lives safer. I hope that in the future all Europeans will be able to benefit from more effective emergency services thanks to caller location solutions."

Commissioner Elżbieta Bieńkowska, responsible for Internal Market, Industry, Entrepreneurship and SMEs said "Satellite navigation is crucial in determining the precise location of the 112 caller and saving lives. Galileo, Europe's own satellite navigation system, will be able to locate the caller with much greater accuracy. The launch of Galileo's initial services and first Galileo smartphones available on the market show how space data is making a difference in daily lives of EU citizens."

HELP 112 tested the AML solution which was initially developed in cooperation between national authorities and industry in the UK. Thanks to this technology, Lithuanian emergency services assisted a little boy who called from home but did not know his address. Emergency services were able to pin down his location and saved his father who had suffered an epileptic seizure. In Austria, woman riding a horse fell on her head and was unable to describe where she was. GNSS provided emergency services with her exact location within seconds, so she could be rescued. In addition to funding research, the Commission is also improving EU rules on 112. Last September the Commission proposed an update of EU telecoms rules in the form of an Electronic Communication Code. The Commission wants to enhance the relevant provisions of the Universal Service Directive in order to facilitate the use of handset based caller location as complement to network based location data.

According to the proposal, Member States will be obliged to ensure that caller location, be it network based (provided by the mobile operator), or handset based (retrieved from a GNSS or WiFi enabled phone), arrives in a timely manner to the Public Safety Answering Point which handles emergency calls. Notwithstanding the technology used, caller location will be free for citizens and the Public Safety Answering Points.

### Live subtitling for TV makes a debut in Poland

Will Iwona Cichosz, Miss Deaf International, win the Polish edition of "Dancing with the Stars"? That we do not know. However, her Deaf and hard-of-hearing fans are now able to follow the show and cheer Iwona on equal basis.

March 10, 2017, was a historic moment for TV accessibility in Poland as for the first time in the country an entertainment show was broadcasted with live subtitling. Polsat, one of the two main commercial broadcasters in Poland, took a bold step to implement live subtitling through respeaking, a technique based involving speech recognition.

It is the first Polish broadcaster who provides such a service.

The decision was taken by the station in reaction to a petition from its viewers. Members of the Deaf community, being unable to watch the first episode of the show, as the station provided no accessibility services at that time, started a petition to Polsat's Board of Directors, requesting live subtitling or sign language interpreting. They were supported by a number of NGOs and media outlets. The broadcaster was guick to respond to viewers' request, taking a decision to broadcast the second and all the following episodes with live subtitles.

Why did the Deaf and hard of hearing must fight for their rights in the first place?

Unfortunately, the Polish law does not require the broadcasters to provide live subtitles. TV stations are only obliged to make sure that 10% of the content they broad-

They use Polish speech recognition software Magic Scribe developed by Radcomp Integral. Subtitles are prepared using a method called respeaking and the text is then monitored and corrected on the fly, which results in high accuracy.



cast is available with either subtitles, audio description or sign language interpreting.

Polsat is the first Polish broadcaster who decided to provide subtitles for a live TV show, what is more, they did that in prime time, when lots of viewers can watch it. "We believe that live subtitling available for this one show is a milestone on the path to a greater TV accessibility in Poland and other prime time broadcasts such as news, sports and entertainment will follow suit," says Monika Szczygielska, the leader of Dostępni.eu team, which helps Polsat provide live subtitling service.

Since 2013 Dostępni.eu team has been providing live transcription services during conferences as well as live subtitling for online streaming of social and political events.

New measure for barrier-free access to banking services

Zurich, March 16, 2017 Mobile induction hearing loops are now available for people with hearing impairments in all of the approximately 140 branches of Credit Suisse in Switzerland. The aim is to simplify communication between hearing impaired clients and counter employees. Credit Suisse is thereby expanding its existing service offering for barrier-free access to banking services. The bank is one of the world's pioneers in this field.

What are known as mobile induction hearing loops are now available to clients with hearing impairments at all of the approximately 140 Credit Suisse branches. Thanks to the hearing systems, clients can have a confidential conversation with counter employees. The device enables audio signals to be amplified through induction and unwanted background noise to be filtered out.

Last year, Credit Suisse carried out a survey in collaboration with the organization pro audito schweiz on the topic of hearing impairments in people's dealings with the bank. The results of this survey showed that communication at bank counters represents one of the main problems for the hard of hearing. As an immediate measure, Credit Suisse set up a pilot project and, during the implementation phase, worked closely with people who are directly affected from the Schwerhörigen-Verein Nordwestschweiz (Northwestern Switzerland Association for the Hard of Hearing). Client advisors and counter employees were familiarized with the devices using training videos and sensitized to dealing with people with hearing impairments. Pictograms at the entrance to branches and at counters indicate the presence of a mobile induction hearing loop system.

### Longstanding Commitment to Barrier-Free Access to Banking Services

Credit Suisse has been committed to barrier-free access to banking services for more than ten years and ensures that people with impaired vision, hearing, and limited mobility encounter no obstacles. This includes a range of measures, such as easy access to branches and ATMs: At selected locations throughout Switzerland, constructional measures were undertaken to position more than 70 ATMs at a lower level so that they can easily be accessed by wheelchair users. Furthermore, around 500 talking ATMs make it easier for people with impaired vision to withdraw cash or check their account balance. Clients with impaired vision can also request their bank statements in large print or braille.

Credit Suisse offers deaf clients the option to have a sign language interpreter present at personal consultations twice a year, free of charge. With its commitment to barrier-free access to banking services, the bank is one of the pioneers not only in Switzerland but also worldwide. Alireza Darvishy, Head of the Center of Accessibility at Credit Suisse, says: "Access to our products and services should be as easy as possible for all our clients. ### Urgent action needed: Ask EU Member States not to ruin the Marrakesh Treaty

Wednesday, 22 March, the Council will meet (Coreper) to vote the final Council compromise proposals on the Directive and the Regulation for the implementation of the Marrakesh Treaty in the EU. According to many reliable sources EU Member States will propose to allow rights holders compensation and commercial availability in the application of the Marrakesh Treaty (in modification of Recital 11). We do not have a final copy of these proposals because they have not been published.

If adopted by the Council, the upcoming negotiations between the European Parliament and Council would be extremely difficult because these Council proposals cross the principal "red-lines" of the promotors of the Marrakesh Treaty in the EU (mainly rights-holders compensation rights and commercial availability). If they entered into law they would have a devastating impact on any successful use of the Treaty in the EU and around the world.

# Seamless passengers' rights across all transport modes? Have your say!

The European Commission recently launched a consultation about passengers' rights across the different transport modes. As you probably know, we already have EU

### rules concerning your rights as a passenger when travelling by plane, train, boat, and coach, including the right to assistance.

But this does not always cover the full journey, for example if you have bought a ticket which combines different transport modes. One example for this is, that you often can get a train ticket at a discount rate when you also buy a plane ticket. These "rail and fly" offers aim at discouraging passengers to travel to the airport by car and avoid congestion, but currently you are not fully covered by EU passengers' rights if for example your train has delay and you miss your subsequent flight.

### Advancing inclusive development and human rights for all persons with disabilities

EDF participated in a meeting in Athens last week to finalise the work with other regional members on a new programme EDF is involved in. It is called "advancing inclusive development and human rights for all persons with disabilities" and is supported by the British Department for International Development (DFID) and the International Disability Alliance (IDA). It was agreed that EDF will coordinate the Flagship 3 of this programme: we will focus on the Sustainable Development Goals (SDGs) regional monitoring and provide technical support to other regional members involved. The regional members involved are the African Disability Forum (ADF), the Arab Organization of Person with Disabilities (AOPD), the ASEAN Disability Forum, the Pacific Disability Forum (PDF) and the Latin American Network of Non-Governmental Organizations of Persons with Disabilities and their Families (RIADIS).

## Activitst Demonstrate for a Strong Law on Accessibility in Europe

On 6 March we demonstrated in front of the European Parliament and we called on Parliamentarians to promote a strong and effective European Accessibility Act. Millions of people in Europe are still excluded from using basic products and services that are taken for granted for other people. Due to lack of accessibility, withdrawing money from a cash machine, entering a bank or any public building, using the metro, issuing a ticket, using a computer, calling a friend, watching TV, staying in a hotel, using a washing machine, are impossible for many people, including persons with disabilities and older people.



### Violence Against women & Girls; Will Europe Rise Up?

This year's celebration of International Women's Day on 8 March comes as a new opportunity for the European Union (EU) to take action against violence against women: the European Commission has declared 2017 the European Year of focused action to combat violence against women and girls.

### First Principal Approval of the European Parliament of Persons with Disabilities

EDF has asked the European Parliament (EP) to co-organise the 4th European Parliament of Persons with Disabilities (EPPD) at the end of 2017. Broadcasters and the umbrella organisation of the European disability movement reached this agreement upon the initiative of the Member of the European Parliament (MEP) Petra Kammerevert, who is preparing the European Parliament's report on the revision of the Audiovisual Media Services Directive (AVMSD).

EDF, EBU and ACT (the "signatories") released a common proposal to introduce progressive and sustainable measures for the delivery of accessible audiovisual programmes in Europe. The signatories expect these measures to enhance the accessibility of TV programmes for persons with disabilities, in particular via subtitles for the deaf and hard of hearing, audio description, spoken subtitles and sign language interpretation, also known as access services.

The common proposal aims to improve existing wording on audiovisual accessibility under Article 7 of the 2010 Audiovisual Media Services Directive (AVMSD), which EU legislators are currently reviewing. A large number of stakeholders and EU decision-makers have highlighted the need to maintain and develop the AVMSD's provisions on access services.

### Progress report of the European Commission on the mid-term review of the European Disability Strategy

On February 2nd, the European Commission presented its Progress Report on the implementation of the European Disability Strategy 2010-2020. The Strategy is EU's main instrument to support the EU's implementation of the UN Convention on the Rights of Persons with Disabilities (UNCRPD).

The progress report gives an overview of the different actions taken by the European Union since 2010 as they are foreseen in the Strategy, and provides progress on the implementation of the Concluding Observations of the CRPD Committee.
