Assistive Listening Devices (ALD) at school – The **HODA**-project

The physical and social context of the classroom as well as teaching methods in addition to handling, functioning and quality of assistive listening devices are the issues comprehensively examined in the HODA-study: evaluation of class room acoustics, observation of an entire lesson, evaluation of communication devices (such as microphones and induction loop systems) in terms of functioning, quality and management during class as well as interviewing pupils (85 girls and boys, aged 10-16) with hearing loss in inclusive education and their teachers. The study was carried out in 2013 in the Stockholm County Council area, Sweden. The HODA-project was initiated and carried through by the Swedish National Agency for Special Needs Education and Schools in close cooperation with the Karolinska University Hospital, Hearing Habilitation Children and Youth. In the following, some of the results are presented.

The acoustic settings were unacceptable in most cases

The joint evaluation of noise and reverberation (measured in the empty classroom) did not meet the official criteria of acceptable or good acoustics in four out of five classrooms. In addition, evaluation of noise generated in the classroom by furniture, doors, windows, nearby indoor or outdoor environment (such as corridors or roads with heavy traffic) indicated that almost half of the pupils with hearing loss as well as their classmates and teachers spend their days in classrooms that are equipped and situated in a way that is not acceptable from an acoustic point of view. When asked if they were disturbed by various sounds during class, more than half of the pupils mentioned noise from classmates and/or corridors, outside activities, other classrooms, ventilation and other sounds.

Moreover, during the classes observed, noise generated by pupils was registered by the observers, in particular during small group activities but also to a large extent during dialogues and discussions in class and even when only one person was talking or when the pupils were supposed to

be working silently by themselves. The vast majority of teachers, on the other hand, evaluated the acoustic quality of the classroom as good and most of them also thought that the school had made reasonable accommodations to meet the needs of pupils with hearing loss. The conclusion is that action to improve the acoustic quality of classrooms in Sweden has to be taken by relevant authorities immediately. Noticeably, bad acoustics impede learning not only for pupils with hearing loss.

The quality of the ALDs was unacceptable in most cases Evaluating 59 assistive listening devices – of which 36 had microphones not only for the teacher but also for the classmates – we found that two out of five worked satisfactorily all through the observed lesson. I.e. more than half of the devices were deficient in one way or another when assessed via the observers ' receivers during class. When asked about most wanted improvements of their ALD, the pupils prioritized "better sound quality" and "faster service". The conclusion is that a plan of action to improve the quality and to carry through systematic and recurrent controls of the devices is due.

There is a lot to be done to improve knowledge and attitudes

Pupils stated that it is important to them that teachers use their microphone, but observations and interviews revealed that teachers ' and classmates ' use of microphones frequently reflect a lack of awareness of the pupil 's needs. Indeed, more than four out of five teachers indicated that they need more knowledge and training in teaching pupils with hearing loss.

To sum up

The HODA-study has provided knowledge about the everyday life at school for pupils with hearing loss. For these pupils to get access to education and to participate and be involved in tasks engaging the entire class and other class activities many issues have to be dealt with. Now.

The Meaning of **Accessible** and **Inclusive** Education for Hard of Hearing Persons

A hard of hearing child is in a classroom of peers without hearing aids, without any support services, without even permission to borrow the school books to study at home.

You might think that I am describing a situation in a country of the global south ... perhaps in an African nation or a rural area in an Asian country. You most likely would not think I am talking about my first five years in school in a developed country and that I went through all of my schooling without support services and accommodations.

It was some time ago and, now if I were a child in school, I am confident I would have hearing aids, an FM system, speech lessons, individual attention from resource room teachers and tutoring assistance if needed. We have come far in so few years. What a wonderful testament to the ability of society to change. It should give us hope for those countries and places which still have inadequate technical and human support for the education of their children and youth. Sadly, we know that is the case in some parts of the world.

We also need to tell others how to get it right. What exactly do we need, how is access and inclusion different and how is it the same from what signing deaf students and hearing students require?

These answers are found in the International Federation of Hard of Hearing People's Education Policy paper adopted at its 2014 BGM in Israel. The policy paper provides guidance to governments and social institutions on the requirements to ensure for an inclusive and accessible education for hard of hearing persons. Accessibility means access and inclusivity takes it a step further to ensure that hard of hearing persons are full participants in the education process.

The paper has been submitted to United Nations agencies, shared with the International Disability Alliance and was provided to the United Nations' Committee on the Convention of the Rights of Persons with Disabilities as part of its April 2015 education general day of discussion.

There are nine recommendations starting with the environment recommending optimum acoustics to maximize speech intelligibility in the classroom. This also requires reducing background noise and sound reverberations. Furthermore, the environment should include visual signals for fire alarms, doorbells, and telephones.

Beyond an optimum environment, students require hearing aids, cochlear implants and assistive listening devices such as induction loops or FM/Infrared systems to maximize auditory sound. It is a principle of IFHOH that no child who requires a hearing aid should go without one. This important principle of hearing aid availability is reinforced in EFHOH's Essen declaration signed in April 2015.

The provision of speech-to-text is another important support service for many hard of hearing persons particularly at upper levels of schooling where the learning becomes the exchange of ideas and exploration of concepts. Videos and audio-visual materials require captions to be accessible to hard of hearing learners.

The policy paper discusses the importance of auditory language development and supports. As well, it supports alternative communication methods for some children, such as the use of gestures, drawings, images, pictographs, and electronic communication aids, etc. Also acknowledged is that the learning of sign language is an option being pursued by some countries in an approach that promotes both auditory and signing skills so that children can grow up to be bilingual.

Support services, parent support, teacher training and social interaction form the basis of other recommendations in the report. Under social interaction, the concept of inclusion means that hard of hearing students have opportunities for social interactions with peers and benefit from exposure to role models. Thus, their inclusion is recognized and fostered.

I invite you to share it with your education policymakers and decision-makers or adapt and develop your own statement for your particular circumstance. Carry on with the important work of ensuring that accessibility and inclusivity applies to hard of hearing learners, whether young or older.



Paris 2016: EFHOH's next Annual General Meeting

EFHOH's next Annual General Meeting (AGM) will be held in Paris from Friday April 1st to Sunday April 3rd. It will be hosted by Bucodes SurdiFrance, which federates most of the French associations of hard of hearing people. Created some 40 years ago, Bucodes SurdiFrance now consists of forty associations spread out all over the French territory. However, compared to many of its EFHOH counterparts, it is a small association since it only gathers some 2500 members.

To host the AGM, we have booked a facility, the Résidence Internationale de Paris (RIP) at Porte de Bagnolet, in the eastern part of Paris.

The RIP has rooms at very reasonable prices, space for meals (breakfasts, lunches, dinners) and meeting rooms, the largest room can accommodate up to 220 people. These rooms have a good acoustic treatment (very little reverberation). Because the RIP building is also the head office of HandiSport, the sports federation of the disabled, the building is accessible to all types of disabilities. Nine months before the event, where are we?

We initially mobilized to find money. We now have an agreement of our partner, the Foundation "Agir pour l'Audition", to finance some major expenses (meals, accessibility, translation...)

Friday, April 1st will be devoted to EFHOH activities (board meeting, general meeting). On Saturday we will organize a major all day long conference with speakers selected by EFHOH and with French specialists in their fields of expertise.

On Sunday, we would organize a cultural and fun day with visits to museums and to typical Paris neighbourhoods, accompanied by bilingual speakers who will speak into a microphone connected to individual HF systems.

Young and hearing loss – how could one get on?

Sigurd Drejer is 16 years old and will turn 17 next year.

Sigurd lives in Denmark and I interviewed him about growing up and getting on with a hearing loss.

"I was 9 months old, when my parents found out about my hearing loss. I didn't react to many sounds, which made my parents worried."

What did your parents do about it?

"They went to the doctor, and I went through a lot of tests. They found out that I had a hearing loss, since I was born. I had my first hearing aids (HA) when I was 11 months old, But I don't really remember what it was like. It is a long time ago".

Can you state 2-3 things that are good about having HAs?

- 1. That I can take them off at the night and sleep well without disturbing sounds.
- 2. When I was younger, I could customize my HA's in a really cool and fun way. I have tons of earplugs from when I was

a little kid, and they are in a billion different colors. There was also a great variety of stickers that you could put on your HA's.

3. I have been a member of different clubs for people/children with hearing loss, and met other children at my age.

That really helped me understanding myself, and it was a great opportunity for my parents too, because they met other parents. Unfortunately, I'm only hanging out with a few friends with HA's, but my parents often spend time with the other kids' parents!

And 2-3 things about HAs that you would rather not have to deal with?

- 1. In general, just to wear them. Not be able to join fun games with water immediately, because I have to take them off first, etc.
- 2. Having to go to the ear doctor often, because the earplug increases earwax in my ear canal, and I can't remove it myself.

3. Sudden howl noises from my HA, when the earplug is too small. It really is awkward in silent places with a lot of people.

Now you have a Cochlear Implant (CI) on one ear? Why did you have to have a CI?

Yes. My parents pondered it when I was little, but it was not that known for children to get CI at that time in Denmark. So I had it about 3 years ago.

How was it to have to hear through your CI? Is there a difference in the sound from HA to CI?

It is different from the HA, because I register some different sounds, which the HA didn't. The CI is registering high pitch sounds, and I couldn't hear many of those sounds when I had a HA on my right ear.

Do you consider getting a CI on the other ear as well? If yes: why?? If no: why??

No, because I like the difference between the CI and HA. The HA can register some sounds that the CI can't. Besides, it wouldn't make a big hearing difference if I got CI on my left ear.

Do you know other children/young people with hearing loss?

I know many other children/young people (and adults) with hearing loss. As I said earlier, I have been a member of some hearing loss clubs for children and young people with hearing loss. It has been a long time since I was on a trip with a club, but I got a lot of friends from the clubs, and I'm still hanging out with a few of them.

Is it important to have friends with hearing loss when you have a hearing loss yourself?

Why?/Why not?

Well it depends on your situation. Do you have a big hearing loss? Don't you feel good when you're together with people without a hearing loss? For me, I have a big hearing loss, but I had always been with other children with a hearing loss, so I can't tell which is better. I haven't hung out with friends with a hearing loss for a while now.

What kind of Assistive Listening Device (ALD) have you had? What has worked best for you?

Right now I'm using Comfort Audio, which is a device that both students and the teacher are using, so I can hear both parts. It is really a great device, but It's also hard. The pupils have to remember to pick up the microphone every time they talk.

You will soon finish comprehensive school and start at a new school August 2015.

Your new school is a boarding school. You will live in with 120 other pupils at this school.

What do you think is important for the others to know about you, when you start?



In reality, it isn't important for them to know anything, it's important for me that they don't see me as the guy with a hearing loss, but as the guy named Sigurd.

What is important for you to know about the others? Nothing much. They just have to be themselves.

Do you have any advice for other children and young people with hearing loss?

If you never really have been with other kids/young people, you really should! It can help if you never have conserved with others with hearing loss. Join clubs, etc.

Is there anything I should have asked that you would like to add?

My advice is that sometimes it is important to know your limits. You can't do anything, you have a hearing loss and you have to accept it. You can try to raise your limits, but don't push yourself too much. If people ask about your hearing loss, don't be shy! Tell them about it. They are just curious, maybe they have never met another person with a hearing loss.

IFHOHYP has been doing this by attending events, meetings, trainings and communicating with various institutions in the past six months. Among others IFHOHYP was represented at the Eighth session of the Conference of the States Parties to the Convention on the Rights of Persons with Disabilities held in June in New York, USA. Board Member, Bowen Tang, has written an article about his trip at the UN Headquarters, which can be found in the latest newsletter of IFHOHYP. Another exciting representation of IFHOHYP and the youth happened in Ireland. Ireland is a wonderful country, not simply because of its beautiful nature, the friendly people, but also because of the association "Hearing Loss Ireland", who invited IFHOHYP to speak at their AGM in order to inspire members to motivate and engage young hard of hearing members in their organization. These Irish ambitions should be a model for HoH organizations all over the world - and in IFHOHYP we will not only encourage but also love

to inspire and help those who wish to include more young hard of hearing people in their organizations.

Historical "Meetings of Committees" and the 2015-2020 Strategy of IFHOHYP

On August 1st the first-ever "Meeting of Committees" in the history of IFHOHYP took place. Young volunteers from all IFHOHYP committees met together with the Board in Brussels, Belgium, to discuss and develop action plans of the committees. Some of the committees in IFHOHYP still have available seats – in other words: If you know a young hard of hearing person, who would like to be a part of the international volunteering work together with other young hard of hearing from all over the world, do not hesitate to contact us – we welcome every young person, who wish to be a part of the IFHOHYP family.

Strengthening the relationship with EFHOH and IFHOH

In April this year IFHOHYP was also represented at the EFHOH Annual General Meeting and the following conference organized by the German Association of Hard of Hearing in Essen, Germany. What more to come in 2015 - and 2016?

There are still exciting activities going on for the rest of 2015. In September IFHOHYP will be a part of an awarenessraising-seminar for D/deaf and hard of hearing people in Athens, Greece organized together with EFHOH. Not long after this, Secretary of IFHOHYP, Ece Saygi, attend a UN CRPD Trainers Workshop in Copenhagen, Denmark. During winter 2015 another "Meetings of committees" will take place, which once again will gather together volunteering young hard of hearing of IFHOHYP.

Finally - I must not forget our Annual General Meeting (AGM), which will take place the 29th of November with our Dutch member organization SH-Jong as host. A two-day international programme, Challenge Life Weekend, will also take place 2 days before the AGM. We are grateful to SH-Jong and are looking very much forward to the gathering of all the IFHOHYP members in the Netherlands.

Looking even further ahead in 2016 the next Summer Camp of IFHOHYP will take place in partnership with Castberggaard in Denmark – make sure all young hard of hearing you know, will save their holiday plans, so they will not miss out on this big chance to have a lot of fun and invaluable life-experiences.

We are thrilled to be offering workshops on the Convention on the Rights of Persons with Disabilities in Europe in October and in New Zealand in January. Due to heavy demand we are now holding two workshops over the week of October 19 to October 23, 2015 in Copenhagen. Our thanks to Louise Carroll for her hard work and to Marcel Bobeldijk, EFHOH President and IFHOH Board member, will be coordinating local arrangements.

Please mark March 3, 2016 for World Hearing Day. IFHOH will be joining with other organizations and the World Health Organization to mark this special day. We are pleased that Richard Darbér, Président du Bucodes SurdiFrance and Treasurer for EFHOH, will represent IFHOH at the WHO-ITU Joint Stakeholders' Consultation on Safe Listening Devices on 1 October 2015 at the WHO headquarters in Geneva, Switzerland. ITU refers to the International Telecommunications Union.

Arnoud van Wijk of the Netherlands represented IFHOH at the UNICEF Consultative meeting on Assistive Products for Children with Disabilities in Copenhagen from July 6 to July 7 this summer. He is extensively involved with issues concerning ICT (Information and Communications Technology) equal access for persons with disabilities. The goal of the forum was provide insights to UNICEF as to what it should do to improve the availability of assistive products

and technologies for children with disabilities. Arnoud ensured that the views of hard of hearing persons were represented in the meeting attended by 75 persons.

IFHOH has been working within the International Disability Alliance to ensure that the UN's post-2015 development agenda is inclusive of persons with disabilities. The document for the agenda will be unveiled in New York on the September 25th weekend and this time, the disability community is included in the text. It calls for "... inclusive and equitable quality education and promotion of life-long learning opportunities for all focuses on eliminating gender disparities in education and ensuring equal access to all levels of education and vocational training for the vulnerable, including persons with disabilities. In addition, the proposal calls for building and upgrading education facilities that are child, disability and gender sensitive and also provide safe, non-violent, inclusive and effective learning environments for all."

Finally, I want to close with thanks to IFHOH board members for their hard work during the past few months; we have met each month, even during the summer! Much volunteer work is being done by board members and I salute each one for their hard work.

THE CONCERNS OF THE DISABILITY MOVEMENT TAKE CENTRE STAGE

Last week, EDF and its members were in Geneva and took part in the examination of the EU by the UN Expert Committee on the Rights of Persons with Disabilities.

On 27-28 August, the UN Committee held a Constructive Dialogue with the EU delegation on the EU's work on the UN Convention on the Rights of Persons with Disabilities (UN CRPD), the first international human rights treaty ever ratified by the EU. On Thursday 3 September the UN Committee will adopt its recommendations for the EU and set the EU agenda for the next years for the human rights of 80 million persons with disabilities in Europe.

EDF was present with many of its European members in Geneva. The EDF delegation consisted of Autism Europe, Inclusion Europe, European Network of (Ex-)Users and Survivors of Psychiatry, Mental Health Europe, European Network on Independent Living, CBM/IDDC, European Federation of Hard of Hearing People, International Federation for Spina Bifida and Hydrocephalus and the European Union of the Deaf.

PRESENTING THE VIEWS OF 80 MILLION PEOPLE WITH DISABILITIES

EDF and members held a side event on 27 August before the start of the EU Constructive Dialogue. EDF and its members presented the priorities on the implementation of the CRPD in Europe and answered to the many questions of the UN Committee members.

The constructive dialogue started on Thursday 27 August in the afternoon and continued on Friday morning on 28 August. The EU delegation consisted of Michel Servoz, Director-General of the Commission's DG Employment, Social Affairs and Inclusion, and his colleagues of the UN CRPD focal point of the European Commission, the Disability Unit of DG Employment, Social Affairs and Inclusion. 20 representatives out of the 28 Member States of the EU were also present as observers.

WHAT DID THE UN ASK THE EU?

Many UN Committee members questioned the EU delegation on its composition and on the absence of representatives of the other EU institutions, in particular DG Justice, the European Parliament and the Council of the EU. During



the dialogue, the Committee posed deep questions on EDF and members' priority issues such as the revision and event on 26 August on the inclusion of persons with distransformation of the European Disability Strategy into a comprehensive strategy to implement the CRPD across alltional cooperation. EU institutions and Member states, the need for a structured dialogue with DPOs in EU decision making, and the need for a CRPD compliant focal point and EU monitoring framework, and the absence of an EU inter-institutional coordination mechanism to implement the CRPD. The use of the EU funds, the absence of comprehensive equal treatment legislation and the European Accessibility Act. intellectual and psychosocial disabilities, hard of hearing years on the rights of persons with disabilities. and deaf persons and expertise on health, international cooperation, and independent living, amongst others.

The EU Monitoring Framework had also the opportunity for a private briefing with the UN CRPD Committee ahead Find: of the dialogue and presented their views on the EU review during the constructive dialogue.

WOMEN WITH DISABILITIES

Earlier last week, on Tuesday 25 August, EDF organised another side event on women and girls with disabilities. Rosa Estaras, member of the European Parliament and EDF Vice President, Gunta Anca, spoke on the discrimination and challenges that women and girls with disabilities face sylviti@edf-feph.org today in Europe. EDF's top three priorities on women and girls with disabilities were all discussed during the constructive dialogue: ratification by the EU of the Council of Europe's Istanbul Convention on violence against women, and the inclusion of the perspectives of women and girls with disabilities in the Commission's post 2015 strategy on gender equality and the recently published road map 'New start to address the challenges of work-life balance faced by working families'.

EDF Director, Catherine Naughton, also spoke at IDDC side abilities in the EU's work on humanitarian aid and interna-

EFHOH - European Federation of Hard of Hearing People

The European Federation of Hard of Hearing People consists of National Associations of/for Hard of Hearing and Late-Deafened People, Parents' Organisations and Professional Organisations.

EFHOH comprises the European members of the International Federation of Hard of Hearing People (IFHOH) and was established in 1993. It has its own board and secretariat. The federation has non-profitable and benevolent aims and it is a non-political and non-sectarian organisation. EFHOH is a general member of the European Disability Forum (EDF). We also work in good co-operation with IFHOH and our official language is English.

The Board members of the EFHOH carry out their work on an honorary basis.
