

Adults with hearing loss in the UK: Self-help during the pandemic

The National Association of Deafened People (NADP) and our activities at this time


Last year our lives changed suddenly and hugely: we had to deal with the fear of the pandemic, isolation, social distancing, and the rapid growth in online meetings. Like in many countries, in the UK cochlear implant surgeries scheduled CI fitting appointments were stopped in response. Some deaf people, about to have an implant and who were looking forward to starting their CI journeys, were left without any means of amplification.

Traditional ways of adapting to the environment ceased. The increased use of face masks took away our traditional way of communication face to face – speech reading, and face masks and screens reduced the audibility of speech making it even more difficult to hear.

NADP is a user and volunteers led charity, and our workload increased as we were trying to find ways to support our members struggling with managing remote work, meetings, and

socialising with these challenges. The face-to-face meetings and conferences which enable knowledge sharing and collaboration have gone, and digital transformation has made a fast forward jump.

NADP's immediate focus was to support people with hearing loss who had to go to hospital and faced communication barriers due to face masks and lack of deaf awareness among hospital staff. Thanks to Euro CIU posting their examples of hospital information cards for CI users, we have produced a similar one, based on the UK situation. Our US colleagues had similar ideas plus having an overnight bag ready, should the worst happen, to ensure we have our gadgets fully charged, disposable batteries stocked, and we have notepad and pen ready. A bit like having a maternity bag ready when it is time to go to hospital to have a baby, just little bit different circumstances! It is so important to have all your communication tools ready in case they are needed!



We also produced <u>resources</u> shared via social media and on our website to support people new to online meetings, communicated tips for organisers of online events and organised online workshop. All those were efforts to get people with hearing loss to feel confident using ICT, online conferencing tools and give them the tools they needed to self -advocate for themselves when access to live captioning is denied.

Many organisations from different countries have started to share resources, knowledge, and the collaboration flourished. The world has truly become smaller thanks to the internet and virtual meetings; many who could never travel to conferences can now participate on line, and the tools to communicate have become so much more accessible than they were before.

Families struggled to stay in touch with their relatives and while some people found virtual meetings liberating as they could lipread, others found lipreading via video not quite the same as in real life. Once again, we came forward with comparison table and best virtual platform for meeting with relatives. We found Google Meet and live captioning is excellent and is relatively easy to activate, it is simply there for anyone who needs it. Our members could not praise it enough, it helped them out of isolation, and they gained confidence to use

technology like never before. This strange time has enabled many, with our support, to become independent and confident in the use of the developing technology, which has changed and become so much more accessible over the past year.

Self help is no longer confined to face to face meetings. Most counselling sessions, group meetings and support work are now online and thanks to live captioning making them more accessible, more people can reach the help they need.

The European Disability Card and the Disability Rights Strategy - What's next?

The EU Disability Card, a blue card with the picture of the owner and name and name of the owner. On the card the name of the card is written in Braille.

The new Disability Rights Strategy 2021-2030 was published by the European Commission in March 2021, after several years of intense advocacy by us and our members.

One of the key items that we wanted to see included was the European Disability Card – and we succeeded! The Card will be one of the "Flagship Initiatives", that means it is one of the most important and visible action, of the new Disability Rights Strategy. And more: the Commission promises to deliver the Card by the end of 2023.
