

In September we attended the IFHOH Conference in Budapest and organised an EFHOH General Meeting which a number of you attended. The meeting gave a number of members a chance to introduce their organisation and talk about their difficulties and their successes. Our presenters were from different parts of Europe: Germany, Austria, Norway, Finland and the Czech Republic prepared interesting presentations.

IAAP Webinar on Accessible Healthcare and Telehealth Services

Lidia organised a webinar on accessible healthcare and telehealth with IAAP, Accessibility Professionals Association this summer. She participated in the webinar together with Dr. Kaloyan Kamenov from WHO. They presented on Making Healthcare services Accessible for deaf and the Hard of Hearing

It stressed the importance of effective communication.

- Video conferencing shall provide captioning and a monitored chat box that has volume control provisions along separate windows.
- Text messaging shall be included as a service to be used when the video or audio are not working well along with the chat box.
- Remote sign language interpretation or a video remote interpretation system should be made available
- Videos on telehealth platforms should include clear subtitles (easy to read and large font size) and avoid background music
- The screen used for telehealth should be large enough for lipreading
