Speakers

Katrin Langensiepen is a Member of the European Parliament since 2019. As the first woman with a visible disability in the Parliament and vice-chair of the *Committee on Employment and Social Affairs* and the *Disability Intergroup*, she fights for a social and inclusive Europe. Her special focus lies on inclusion in employment and, together with different NGOs, she worked on the report on equal treatment in employment and occupation in light of the UNCRPD, that demands better inclusion of persons with disabilities in the first labour market and an end to exclusionary practices.

Nicole Sophie Marinos is a strong advocate for people with disabilities, actively working to challenge perceived limitations and promoting inclusion within both educational and professional settings. Through student organisations and volunteering, Nicole Marinos has been involved in initiatives that promote equal opportunities, accessible education, and inclusive environments for all students. She is particularly interested in exploring how policy, education, and technology can be leveraged to support individuals with disabilities and create more inclusive spaces.

Jonathan Elebjörk Wahlström is a lawyer who currently works as Secretary General for the Swedish organisation of young hard of hearing people. He is EFHOH's Representative and Co-Chair in the European Disability Forum Youth Committee, Board Member of the Swedish National Council of Youth Organisations and has a wide interest in human rights and democracy, as well as in accessibility for persons with disabilities.

Mark Laureyns is an audiologist and speech pathologist, president of the European Association of Hearing Aid Professionals (AEA), and director of the Amplifon Centre for Research and Studies in Milan. He lectures on hearing aid fitting at Thomas More University in Antwerp and co-chaired the WHO's "Make Listening Safe" workgroup until 2023. His research focuses on safe listening, hearing and cognition, and professional hearing care.

Jiska Peeters is staff member, in the Communications and Marketing Department at Thomas More University of Applied Sciences in Belgium. Born with significant hearing loss, Jiska Peeters shares her experiences at the University in Belgium, where she talks about her personal story and frequently connects it to the impact of technological innovation in hearing rehabilitation.

Shelly Chadha is the technical lead for the World Health Organization's work in the field of ear and hearing care, being responsible for prevention of deafness and hearing loss, advocacy for prioritisation of hearing care and technical support to countries for development of hearing care strategies. The major initiatives she leads include the Make Listening Safe initiative, the World Hearing Day, the World Report on Hearing and the World Hearing Forum.

Lidia Best is president at the European Federation of Hard of Hearing People (EFHOH) and chair of JCA-AHF (Joint Coordination Activities on Accessibility and Human Factors) at the International Telecommunication Union. As an advocate with lived experience, she focuses on accessibility, research, policy, and empowering deafened and hard of hearing advocates. Lidia Best actively works on raising awareness and changing societal and systemic attitudes towards people with hearing loss.
